of the other part, have agreed as follows:

**PROJECT No. CB007.1.11.220-PP2 ; “Tourism and traditions – colorful, entertaining, attractive”**  
**under Interreg-IPA II CBC Bulgaria-Serbia Programme, CCI Number: CCI 2014TC16I5CB007**

**CONTRACT TITLE Construction works at Vidriste area - as per technical specification and design**

**Identification number CB007.1.11.220-PP2-TD2**

Whereas the Contracting Authority would like the Contractor to carry out the following works:

**infrastructure investment works in Vidriste location (near to City of Nis) duly follow the approved Technical Design according to PRAG requirements and applicable national legislation. In general investment works activities include infrastructure for the convenience of the tourists and visitors:**

- **22 hexagonal wooden marquees;**
- **8 round picnic tables for 8 persons each of them;**
- **2 sales wooden stalls;**
- **25 waste baskets;**
- **18 wooden benches, 2 wooden information boards and 3 road signs;**
- **3 pedestrian paths: from village Miljkovac to Vidriste, to the tower “Zeleznik” and along the Toponica river;**
- **placement of 30 poles with solar lighting;**
- **local Wi-Fi access to the Internet.**



and has accepted a tender by the Contractor for the execution and completion of such works and the remedying of any defects therein.

**It is hereby agreed as follows:**

- (1) In this Contract, words and expressions shall have the meanings assigned to them in the contractual conditions set out below.
- (2) The following documents shall be deemed to form and be read and construed as part of this Contract, in the following order of precedence:
- the Contract,
  - the Special Conditions,
  - the General Conditions,
  - the Bill of Quantities (after arithmetical corrections) and Detailed Breakdown of Prices,
  - the Technical and /or Performance Specifications,
  - the Design Documentation (drawings),
  - the tender,
  - any other documents forming part of the Contract.

The various documents making up the contract shall be deemed to be mutually explanatory; in cases of ambiguity or divergence, they shall prevail in the order in which they appear above. Addenda shall have the order of precedence of the document they are amending.

- (3) In consideration of the payments to be made by the Contracting Authority to the Contractor as hereinafter mentioned, the Contractor undertakes to execute and complete the works and remedy defects therein in full compliance with the provisions of the Contract.
- (4) The Contracting Authority hereby agrees to pay the Contractor in consideration of the execution and completion of the works and remedying of defects therein the amount of:
- Contract price (excluding VAT/other taxes) **213.970,68** EUR
  - Contract price (in words ) two hundred thirteen thousand nine hundred seventy euro and sixty eight cents EUR

or such other sum as may become payable under the provisions of the Contract at the times and in the manner prescribed by the Contract. VAT shall be exempted from payment under the contract between EU and Republic of Serbia. VAT will be paid in compliance with the binding regulations, national law and international agreements concerning the execution of the project. VAT and other taxes shall not be paid on the funds originating from EU funds.

In witness whereof the parties hereto have signed the Contract. This Contract shall take effect on the date on which it is signed by the last party, namely the Contractor.
