

## Clarifications No 1 to the TENDER DOSSIER

Publication Ref.: CB007.1.31.217-004

### Subject: Supply of fire and flood equipment under the project “Joint management of risks in the region - Niska Banja and Kostenets”

The following questions of general interest have been raised in the course of the tender procedure. In accordance with standard procedures, the answers to these questions are hereby disseminated to all tenderers.

#### Question No 1:

In point 15 “Selection criteria”, p. 3) “Technical capacity of tenderer” from the Contract notice you have written the following criteria for legal persons for LOT 1-5:

- *the tenderer has delivered supplies under at least 1 contract with a budget of at least value Tenderer’s financial proposal in the field of technique/equipment for emergency situations against fire and/or flood, which were implemented during the following period: 3 years from the current submission deadline;*
- *the tenderer has delivered supplies under at least 1 contract for technique/equipment for LOT for which are submitting proposal, which were implemented during the following period: 3 years from the current submission deadline.*

If a tenderer decides to apply for “LOT-1 Supply of fire fighting Vehicle”, for example, **how many implemented contracts he needs to present in order to satisfy with the selection criteria for technical capacity?** A previous implemented contract in the field of supply of equipment for emergency situations against fire is in the same time a contract for equipment for Lot 1 – the lot for which the tenderer is applying, i.e. one implemented contract can be applicable to both bullets above. In this case, shall the tenderer still provide two different contracts for supply of equipment in the field of fire management?

#### Clarification No 1:

Please note that the Contracting Authority cannot give a prior opinion on the assessment of the tender. The tenderer should comply with both requirements as listed in point 15 “Selection criteria”:

##### For LOT 1-5

- the tenderer has delivered supplies under at least 1 contract with a budget of at least value Tenderer financial proposal in the field of technique/equipment for emergency situations against fire and/or flood, which were implemented during the following period: 3 years from the current submission deadline
- the tenderer has delivered supplies under at least 1 contract for technique/equipment for LOT for which are submitting proposal, which were implemented during the following period: 3 years from the current submission deadline

##### For LOT 6

- the tenderer has delivered supplies under at least 1 contract in the field of technique/equipment for surveillance activities: 3 years from the current submission deadline

**Question No 2:**

“In addition, in bullet one above, what do you mean by “the tenderer has delivered supplies under at least 1 contract with a budget of at least value Tenderer’s financial *proposal*” – the tenderer’s financial proposal for all lots, if the tenderer is applying for more than one lot, or the tenderer’s financial proposal lot by lot?”

**Clarification No 2:**

For LOT 1-5 the tenderer should have delivered supplies under at least 1 contract with a budget of at least value Tenderer’s financial proposal in the field of technique/equipment for emergency situations against fire and/or flood. In case the tenderer is applying for more than one lot – the contract shall be with a budget of at least Tenderer financial proposal as a cumulative value of the lots he is applying for.

**Question No 3:**

In the technical description you request: “L-shaped reservoir from GRP, with a capacity of not less than 400 l, including not less than 380 l of water and not less than 20 l foam”. Do you accept other types of reservoirs other than the L profile, except that the shape of the tank absolutely does not affect the functionality of the vehicle?

**Clarification No 3:**

We are not in the position to change the technical specification of the tender.

**Question No 4:**

Do we need performance guarantee for participation in the tender?

**Clarification No 4:**

Performance guarantee is not required for participation in the tender.

**Question No 5:**

What is the correct date for submission of the tenders?

**Clarification No 5:**

The deadline for submission of the tenders is 25.10.2017. at 13:00 (Serbia time) as stated in Instructions to tenderers.
