The financing for this contract will be provided under Subsidy Contract № PД-02-29-82/16.05.2019, Budget line 5 – Equipment and Works. The maximum amount of the contract is 427 831.25 BGN without VAT (513 397.50 BGN with included VAT).

6. Description of the contract

The subject of this contract is the supply of joint integrated system for early warning of floods, comprising of 4 automatic combined stations, information system and situational centre equipment, for the needs of Municipality of Etropole within project № CB007.2.31.178 "Setting up of a system for prevention and early warning of floods", financed under Interreg-IPA CBC Bulgaria – Serbia Programme. Detailed technical specifications of the system and its components are given in Annex II + III: Technical specifications + Technical offer.

7. Number and titles of lots

One lot only.

TERMS OF PARTICIPATION

8. Eligibility and rules of origin

Participation is open to all natural persons who are nationals of and legal persons (participating either individually or in a grouping – consortium – of tenderers) which are

effectively established in a Member State of the European Union or in a eligible country or territory as defined under the Regulation (EU) No 236/2014 establishing common rules and procedures for the implementation of the Union's instruments for external action (CIR) for the applicable instrument under which the contract is financed (see also heading 22 below). Participation is also open to international organisations.

All supplies under this contract must originate in one or more of these countries.

9. Grounds for exclusion

Tenderers must submit a signed declaration, included in the tender form for a supply contract, to the effect that they are not in any of the situations listed in Section 2.6.10.1. of the practical guide.

Tenderers included in the lists of EU restrictive measures (see Section 2.4. of the PRAG) at the moment of the award decision cannot be awarded the contract.

10. Number of tenders

Tenderers may submit only one tender. Tenders for parts of the procedure will not be considered. Tenderers may not submit a tender for a variant solution in addition to their tender for the supplies required in the tender dossier.

Any tenderer may state in its tender that it would offer a discount in the event that its tender is accepted for more than one lot.

11. Tender guarantee

No tender guarantee is required.

12. Performance guarantee

The successful tenderer will be asked to provide a performance guarantee of 5% of the amount of the contract at the signing of the contract. This guarantee must be provided together with the return of the countersigned contract no later than 30 days after the tenderer receives the contract signed by the contracting authority. If the selected tenderer fails to provide such a guarantee within this period, the contract will be void and a new contract may be drawn up and sent to the tenderer which has submitted the next cheapest compliant tender.

13. Information meeting and/or site visit

No information meeting is planned.

14. Tender validity

Tenders must remain valid for a period of 90 days after the deadline for submission of tenders. In exceptional circumstances, the contracting authority may, before the validity period expires, request that tenderers extend the validity of tenders for a specific period (see para 8.2 of the instructions to tenderers).

15. Period of implementation of tasks

The period for implementation of the tasks is 240 days from contract signature.

SELECTION AND AWARD CRITERIA

16. Selection criteria

The following selection criteria will be applied to tenderers. In the case of tenders submitted by a consortium, these selection criteria will be applied to the consortium as a whole unless specified otherwise. The selection criteria will not be applied to natural persons and single-

member companies when they are sub-contractors:

1) Economic and financial capacity of tenderer (based on i.a. item 3 of the tender form for a supply contract). In case of tenderer being a public body, equivalent information should be provided. The reference period which will be taken into account will be the last three financial years for which accounts have been closed.

<u>Legal persons:</u>

• The average annual turnover of the tenderer for the last three years for which accounts have been closed must exceed the maximum budget of this contract.

Natural persons:

- The available financial resources of the tenderer must exceed the maximum budget of this contract.
- 2) Professional capacity of tenderer (based on i.a. items 4 and 5 of the tender form for a supply contract). The reference period which will be taken into account will be the last three years preceding the submission deadline.

Legal persons:

- The tenderer has the following quality certificates appropriate to this contract:
 - -ISO 9001:2015 or equivalent with scope in the field of geographic information systems /GIS/;
 - -ISO 27001:2013 or equivalent with scope in the field of geographic information systems /GIS/;
 - -ISO 20000-1:2011 or equivalent with scope in the field of geographic information systems /GIS/.
- The tenderer has the following key experts necessary for the implementation of the contract:

1. Project Manager

Requirements: University degree in the field of information technologies, telecommunications or equivalent. Minimum 5 years professional experience in the field of information technologies as a Project Manager. To have a Project Management Professional /PMP/ Certificate or equivalent. Participation in minimum 1 project including construction and maintenance of an integrated system – solution for management and protection against disasters and accidents and/or construction of a backup data centre.

2. Expert GIS /Geography Information System/

Requirements: University degree in the field of information technologies or equivalent. Additional qualification in the field of GIS /Geography Information System/. Minimum 5 years professional experience in the field of information technologies. Participation in minimum 1 project including delivery and implementation and/or development and implementation of a GIS based information system.

3. Expert Geo database

Requirements: University degree in the field of information technologies or equivalent. Minimum 5 years of professional experience in the field of information technologies. Participation in minimum 1 project including the

delivery and implementation and /or development and implementation of a GIS based information system.

4. Expert Telecommunications

Requirements: University degree in the field of information technologies, telecommunications or equivalent. Minimum 3 years professional experience in the field of information technologies. Participation in minimum 1 project including construction and maintenance of an integrated system – solution for management and protection against disasters and accidents and/or construction of a backup data centre.

Natural persons:

- The tenderer is currently working as manager with 1 collaborator in fields related to this contract.
- 3) Technical capacity of tenderer (based on i.a. items 5 and 6 of the tender form for a supply contract). The reference period which will be taken into account will be the last three years preceding the submission deadline.

Legal and natural persons:

• The tenderer has delivered supplies under at least 2 contracts with subject similar with the subject of this tender procedure, which were implemented during the following period: 09.10.2016 – 09.10.2019.

Under "similar with the subject of this tender procedure" should be understood: delivery and implementation or development and implementation of GIS based information system and/or construction and maintenance of an integrated system – solution for management and protection against disasters and accidents and/or construction of a backup data centre.

This means that the contract the tenderer refers to could have been started or completed at any time during the indicated period but it does not necessarily have to be started and completed during that period, nor implemented during the entire period. Tenderers are allowed to refer either to projects completed within the reference period (although started earlier) or to projects not yet completed. In the first case the project will be considered in its whole if proper evidence of performance is provided (statement or certificate from the entity which awarded the contract, final acceptance). In case of projects still on-going only the portion satisfactorily completed during the reference period will be taken into consideration. This portion will have to be supported by documentary evidence (similarly to projects completed) also detailing its value.

Capacity-providing entities

An economic operator may, where appropriate and for a particular contract, rely on the capacities of other entities, regardless of the legal nature of the links which it has with them. If the tenderer relies on other entities it must prove to the contracting authority that it will have at its disposal the resources necessary for performance of the contract by producing a commitment on the part of those entities to place those resources at its disposal. Such entities, for instance the parent company of the economic operator, must respect the same rules of eligibility and notably that of nationality, as the economic operator relying on them and must comply with the selection criteria for which the economic operator relies on them. Furthermore, the data for this third entity for the relevant selection criterion should be included in the tender in a separate document. Proof of the capacity will also have to be provided when requested by the contracting authority.

With regard to technical and professional criteria, a tenderer may only rely on the capacities of other entities where the latter will perform the tasks for which these capacities are required.

With regard to economic and financial criteria, the entities upon whose capacity the tenderer relies, become jointly and severally liable for the performance of the contract.

19. Deadline for submission of tenders

The tenderer's attention is drawn to the fact that there are two different systems for sending tenders: one is by post or private mail service, the other is by hand delivery.

In the first case, the tender must be sent before the date and time limit for submission, as evidenced by the postmark or deposit slip¹, but in the second case it is the acknowledgment of receipt given at the time of the delivery of the tender which will serve as proof.

Any tender submitted to the contracting authority after this deadline will not be considered.

The contracting authority may, for reasons of administrative efficiency, reject any tender submitted on time to the postal service but received, for any reason beyond the contracting authority's control, after the effective date of approval of the evaluation report, if accepting tenders that were submitted on time but arrived late would considerably delay the evaluation procedure or jeopardise decisions already taken and notified.
